### 香港Q嘜優質產品計劃使用規則概要

#### Summary of the rules and regulations governing the Hong Kong Q-Mark Product Scheme

1. 香港工業總會轄下的香港優質標誌局〔簡稱「優標局」〕是獨家簽發「香港Q嘜優質產品計劃」准用証的機構。任何公司 倘欲認証「香港Q嘜優質產品計劃」,應向「優標局」提出申請。

The Hong Kong Q-Mark Council, Federation of Hong Kong Industries is the sole authority to provide certification of the Hong Kong Q-Mark Product Scheme. Any application for certification shall be addressed to the Hong Kong Q-Mark Council.

2. 凡申請「香港Q嘜優質產品計劃」准用證的公司,須經香港優質標誌局審定其產品確實符合指定標準,方可獲簽發「香港Q嘜優質產品計劃」准用證。

A licence will normally be granted only to applicants who satisfy the Council that they are the manufacturers of products that comply with the prescribed standard.

3. 申請「香港Q嘜優質產品計劃」准用証的公司,經本局審定為確能生產符合指定標準的產品,並按香港優質標誌局的要求 作出保證。

An applicant who satisfies the Council that he/she is capable of complying with the prescribed standard and who gives the Council such an undertaking as it may require and who is subject to the conditions of the rules and regulations governing the Hong Kong Q-Mark Product Scheme, may be granted a licence.

4. 「優標局」有充分權力

The Council has absolute authority to:

- a. 拒絕簽發或續發准用証
  - refuse to grant or renew a certificate;
- b. 吊銷已發出的准用証 revoke a certificate already granted.
- 5. 領有「香港Q嘜優質產品計劃」准用証的公司必須

A licencee shall:

- a. 導照指定標準及任何修定(此類修訂當預先通知獲認証公司);
  - conform with the prescribed standard and with any amendment to it (of which he/she will be notified);
- b. 全面遵照經「優標局」批准的監管計劃
  - comply in all respects with the scheme of supervision and control, as approved by the Council;
- c. 容許「優標局」的人員在辦公時間內進入生產獲准使用「Q嘜」優質標誌的產品的廠房,查驗生產原料、生產工序,製成品、檢定方法和品質管制的記錄;
  - give representatives of the Council unobstructed access, during working hours, to the premises in which licensed products are manufactured, for the purpose of examining materials, processes, finished products, methods of testing and quality control records;
- d. 負責工廠巡查、產品檢定及實施監管計劃所涉及的一切費用,收費概由本局根據營管成本不時予以合理釐訂;
  - pay all fees in connection with surveillances, testing and administration, as well as from time to time be determined by the Council to be fair, having regard to the costs relating to its Q-Mark licence;
- e. 首先取得「優標局」批准,方可在產品、廣告、宣傳印刷品上或任何其他方式使用「香港Q嘜優質產品計劃」標誌或有關信息;
  - secure prior approval from the Council to make any use of the Hong Kong Q-Mark Product Scheme's logo and related messages on products, in advertisements, promotional materials or any other means;
- f. 在准用証有效期終止之後即時全面停止使用「香港Q嘜優質產品計劃」標誌及帶有這個標誌的信息,並完全不再提及「香港Q嘜優質產品計劃」標誌和有關信息

discontinue all use of the Hong Kong Q-Mark Product Scheme's logo and messages or any reference thereto upon the termination of the certificate.
