



目的：

為讓本澳時尚創意行業人士及相關課程學員能夠利用現今市場上的技術，提昇創作和生產力，澳門生產力暨科技轉移中心成衣技術匯點設置數碼印布及數碼直噴印花系統，協助利用數碼印花技術直接將樣品打印在布料及服裝成品上，達至快速回應的效果。

服務對象：

本澳的製衣廠商、時裝設計師、文創人士及設計學生等。

服務期：

製作期一般為落實資料後的三個工作天。但因應製作量，服務期可能會有所不同，實際交貨日期需商議決定。如客戶在收貨後三個工作天內沒有向本中心提出問題，則代表認可是次服務。

版權：

所有客戶提供的設計圖樣均會被保密。假如 CPTTM 希望使用客戶的設計圖樣，必先徵得客戶的同意才進行。

備註：

- (1) 此服務適合用於樣辦製作用途，並不適合大量生產。
- (2) 本中心只負責印製，不作任何調色及對色。
- (3) 服務條款的解釋權歸 CPTTM 所有。

數碼印布機

使用辦法：

如需使用服務，請填妥服務申請表(AT/015)，連同設計檔案(儲存在 USB、光碟等)，送交成衣技術匯點。

費用：

- 客戶自備布料，打印及後處理以每 1/2 米長度計算，收費為澳門幣 50 元。
- 如購買本匯點提供的特定布料，以每 1/2 米長度計算，按定價表收費。打印及後處理以每 1/2 米長度計算，收費為澳門幣 50 元。
- 如客戶印製絲巾樣辦後要求包邊服務，基本收費為澳門幣 50 元(周邊長 352cm 或以下)。如周邊長超過 352cm，則每增加 40cm，需加收費用澳門幣 10 元，如此類推。

限制：

- (1) 數碼印布機接受布封不能超出 150 厘米，同時自備之布料印花後不能洗水。
 - (2) 印布圖檔建議採用 TIFF 圖像格式，解像度為 300 dpi。
 - (3) 數碼印布機採用之印布顏料為數碼印布化學顏料，若經過化學劑(例如漂白劑、乾洗劑等)高溫暴曬或高溫整燙處理後，將會引致列印色彩褪變。

數碼直噴印花機

使用辦法：

如需使用服務，請填妥服務申請表 AT/015，連同設計檔案(儲存在 USB、光碟等)，以及打印布料/服裝成品(須提供適量作試辦)，送交成衣技術匯點。

費用：

- 服務費用按每一幅圖檔的打印面積計算，首 100cm²內收費澳門幣 25 元 (基本收費)。
- 如超出 100cm²，除基本收費澳門幣 25 元外，其後每 8cm²收取澳門幣 1 元。
- 總費用以整元收費。

限制：

- (1) 印花圖檔的打印尺寸最大不能超越 35cm x 40cm。
- (2) 印花圖檔建議採用 PNG (透明去底)圖像格式，解像度為 300 dpi。
- (3) 數碼直噴印花只適用於服裝布料上(最適宜含棉量較高的布料)，且該布料須耐熱、不防水。
- (4) 布料/服裝成品印上圖案後，建議於 3 天內進行洗滌；否則可能會影響布料/服裝成品的手感。
- (5) 為確保印花效果，使用服務時必須提供適量樣品作測試。

Objectives:

In order to enable Macao's fashion and creative industry professionals and related course students to utilize the technology in the market today to enhance their creativity and productivity, the Macao Productivity and Technology Transfer Center sets up digital printing and digital direct printing systems to assist in the use of digital printing on garments and products. The technology directly prints samples on fabrics and finished garments for fast response.

Service Prospective:

Local garment factories, fashion designers, creative persons and design students.

Service Period:

The production period is generally three working days after the implementation of the information. However, depending on the amount of production, the service period may vary, and the actual delivery date is subject to negotiation. If the customer does not question CPTTM within three working days after receiving the goods, the representative will recognize the service.

Copyrights:

For the benefit of our clients, all the pattern designs are kept in confidential. CPTTM would request for permissions from clients if the pattern designs were used.

Note:

- ◇ This service is designed for making of printing sample; it is not designed for mass printing design.
- ◇ CPTTM is only in charge of the fabric printing process but not responsible for any color correction or color matching.
- ◇ CPTTM reserves the final interpretation right to the service terms.

Digital Printing Machines

Service Application:

Please fill in the service application form (AT/015), together with the design file (saved in USB, CD ROM, etc.), and submit to House of Apparel Technology (HAT).

Charges:

- ◇ Fabric provided by clients: MOP50.00 per half meter in length for printing and treatment.
- ◇ Special fabric purchased from H.A.T.: Fabric price is shown on price list (Based on every half meter in length). MOP50.00 per half meter in length for printing and treatment.
- ◇ Finishing edge of silk scarf sample: the basic charge is MOP50 (the perimeter is 352cm or less). If the perimeter is longer than 352cm, for every 40cm, additional MOP10 will be added up, and so on.

Restrictions:

- ◇ The width of the fabric cannot be over 150cm for the digital fabric printing. Fabric provided by clients cannot be washed after printing.
- ◇ Fabric Printer are recommend to be in "TIFF" (Graphic) format, the resolution in 300 dpi.)
- ◇ The printing colors in this service is digital fabric printing chemistry colors. If it passes through chemical (eg. bleach and dry-cleaning agent etc), exposing to sunshine in high temperature or ironing in high temperature, it will result in color fading.

Digital Direct Printing Machines

Service Application:

Please fill in the service application form (AT/015), together with the design file (saved in USB, CD ROM, etc.) and submit to House of Apparel Technology (HAT). Please also provide enough material for sampling.

Charges:

- ✧ Service charge is calculated base on the printing size of the graphic, the price for the first 100 cm² is MOP25 (basic fee).
- ✧ If the size of the graphic is over 100 cm², except for the base change MOP25, every 8 cm² will cost MOP1.
- ✧

Restrictions:

- ✧ The size of the printing graphic can not exceed 35cm x 40cm.
- ✧ Fabric Printer are recommended to be in "PNG" (Transparent background) format, the resolution in 300 dpi.
- ✧ Only garment fabrics (cotton fabric are ideal) are suitable for Digital Direct Printing, and with high heat resist but no water resist.
- ✧ It is recommended to wash the fabric/ garment product within 3 days, after graphics being printed on, otherwise it may affect the feel of the finished fabric/clothing.
- ✧ In order to ensure the printing effect, an appropriate amount of sample must be provided for testing when using the service.
